The Route to Professional Qualification in Shipping

METL provide evening courses in central London for the Professional Qualifying Examinations leading to membership of the Institute of Chartered Shipbrokers.

The Institute of Chartered Shipbrokers (ICS) is the professional body, internationally accepted for all those engaged in every aspect of shipping business.

METL have a team of knowledgeable lecturers all of whom are professional shipping experts in their own fields.

Who are the courses designed for?

These part-time evening courses are designed primarily to prepare candidates for the Qualifying Examinations leading to membership of the Institute of Chartered Shipbrokers (MICS), the Foundation Diploma of the Institute of Chartered Shipbrokers and the Advanced Diploma of the Institute of Chartered Shipbrokers.

The courses' content will also be of interest to those wishing to expand their knowledge of the shipping business without necessarily having to sit for an examination.

About the courses

The courses adhere to the rules and regulations as set out by the Institute of Chartered Shipbrokers and it is the candidate's own responsibility to comply with these obligations.

Candidates must pass a total of seven subjects (unless the Institute grants any exemptions to a candidate) to enable them to apply for election to become a Member (MICS) of the Institute and eventually go on to Fellowship (FICS) when the title of 'Chartered Shipbroker' can be used.

Subjects are arranged into three groups as follows:-

Group 1

- Introduction to Shipping
- Legal Principles in Shipping Business
- Economics of Sea Transport and International Trade
- Shipping Business

Note: All subjects in Group 1 are required
Shipping Business is compulsory in first year

Group 2

- Dry Cargo Chartering
- Ship Operations and Management
- Tanker Chartering
- Ship Sale and Purchase
- Liner Trades
- Port Agency
- Logistics & Multi-modal Transport
- Port and Terminal Management
- Offshore Support Industry

Note: Exemptions may be permitted from these subjects

Group 3

- Shipping Law
- Shipping Finance
- Marine Insurance

Important Notes:

Professional Qualifying Examination (PQE)

Shipping Business **MUST** be taken in the first year along with one other subject of your choice (**Note:** the second choice subject cannot be Introduction to Shipping). Please note that the majority of students take **three** subjects in their first year of study for the PQE qualification. The remaining subjects up to the seven required may then be taken in any order.

Foundation Diploma of the Institute of Chartered Shipbrokers

For those new to shipping or with little industry experience you may consider studying for the Foundation Diploma. Candidates have to take and pass both subjects at the same set of examinations. You have to take Introduction to Shipping from Group 1 and one other subject from Group 2. No exemptions are allowed.

Advanced Diploma of the Institute of Chartered Shipbrokers

For those with some basic knowledge of the shipping industry, you may consider studying for the Advanced Diploma. Candidates have to take and pass both subjects at the same set of examinations. You have to take Shipping Business from Group 1 and one other subject from Group 2. No exemptions are allowed.

Exemptions

Apart from Shipping Business you may be able to gain exemptions. Candidates must apply directly to the Institute of Chartered Shipbrokers for validation of any relevant professional or educational qualifications.

Assessment

Assessment is by external examinations set by the Institute of Chartered Shipbrokers. These examinations take place each year during the month of April at a centre in London and at many centres worldwide.

Important Points to Note

Please bear in mind the following:-

- When making your selection of subjects remember that Shipping Business is compulsory in the first qualifying year and that you have to take one other subject at your first qualifying attempt if you are taking the full Professional Qualifying Examinations (PQE). **Note:** your second choice subject cannot be Introduction to Shipping.
- Most candidates are working full-time and so generally take three years to complete the course towards full membership of ICS. Do not, therefore, be too ambitious at your first attempt.
- Even if you are granted an exemption in a particular subject, you may need that knowledge for some of the other subjects. Study the syllabus for that subject and attend the classes if you are uncertain about any aspect of the subject matter. This applies particularly to Introduction to Shipping, as most other subjects demand a good understanding of this subject.

The Institute of Chartered Shipbrokers

In order to take the ICS Examinations, you have first to register with the Institute as a student, which will then allow you to claim any exemptions if applicable.

Secondly, you have to complete an entry procedure for the examinations themselves. Application Forms for both Registration and Examination Entry are obtained direct from the Institute and the respective fees paid to ICS.
